**All Vendor storage will be in a designated area near the France Equestrian Center. Please contact Fair staff, before you store, to assure you are in the proper location. If you are not stored in the proper location you will lose future storage opportunity.**

This agreement is between the Alaska State Fair, Inc. and the above lessee.

- Fair grants to lessee permission to store his Fair booth on the Fairgrounds. *When the booth is removed from storage for use during fairtime nothing will remain in the storage area. All items left in the storage area during fairtime will become property of the Alaska State Fair and promptly removed.*
- Payment must accompany this form. Lessee agrees to pay the Fair the sum of \$250.00, by September 30. If paid after September 30, \$50 penalty per month is charged.
- Lessee agrees to move booth to the designated storage area, determined by Fair staff, no later than September 11, unless contracting with a commercial mover. (see reverse)
- Booth storage shall begin September 7, 2010 and shall end August 24, 2011.
- **Lessee shall have Fair approval for access to storage. During the month of July the storage area will be open for working on booths. Please schedule with Pamela (746-7159).**
- Fair is not responsible for loss, theft, fire, vandalism, weather damage, or other damage in any way to the booth.
